Then the atmosphere became purer, and everybody seemed to breathe more freely.

A TRIVIAL AMOUNT

"What amount do you owe the defendant?" asked Mr Knight, P.M., at the Police Court on Tuesday in a ?? case, and Joseph Templeton replied, "Nine shillings for work done." "Oh, that's a trivial amount. How are you going to get costs?" asked the police magistrate of Mr Abernethy, who represented the plaintiff, Elizabeth Howell, boar house-keeper, in a claim against George Porter, for £3)s 6d. Mr Knight: "It is a singular thing that the man's address cannot be found in a place like Victoria, which is small enough, surely. Case adjourned for eight days."

On the motion of Mr A C Tuthill (of Messrs Grand and Tuthill), Mr R Knight P. M, at the Police Court on Tuesday, granted H J Jennings an order against F E Camm for £1 3s, with 15s 6d costs, duo on a promissory note. Martin Cussen and Co. (on the application of Mr Abernethy), were granted an order for £39 15s 7d, with £2 17s 6d costs (also due on a promissory note).

ACCIDENT IN MAUDE STREET

Mr Dobson, of the Shepparton Estate, was leading a horse and gig to Maude street yesterday at about 11 30 a.m. (the gig being loaded with timber), when the animal was startled and bolted into the right-of-way at the rear of Mr W MacDermott's store, where the gig came to grief at the gate, it being wrecked. Mrs Dobson, who is a young woman, was knocked down, the wheel passing over her head; but she was picked up by some of the spectators and taken into the Union Hotel. Her nose was broken, and she also sustained a cut on the forehead and another at the back of the head. Dr J M'Kenna attended to the injuries, and advised the sufferer's removal to the Mooroopna Hospital. He does not consider that the injury to the nose will cause any deformity.

IS CHRISTIANITY A FAILURE?

Messrs Stanley Paul and Co. publishers, of the Strand, London, forward us a copy of their latest publication entitled "Is Christianity a Colossal Failure?" The work is copiously illustrated, and deals with how England treats her women; the lack of Christian spirit in commercial and business life, and in the political world; the lack of equity and justice in the world of law and legal administration; the drink traffic and the children of the poor; and a final protest and a straight talk to ministers of religion. It is a pathetic narrative all through, forcibly written, one that makes the individual's blood boil to know that such terrible conditions of existence should continue in the very heart of the Empire, where starvation wages are paid for good but life-destroying work through long hours of day and night ; and where many thousands of families struggle through from year to year, just able to keep body and soul together. But why Christianity should be blamed or condemned for this state of things is not quite apparent. It opens the way for a long argument, in which the considerations of a not too extensive country with a numerous population, and a free trade policy that opens the door widely to the foreigner greatly detrimental to local competition, must loom largely. The matter lies in the hands of the people themselves who send their representations to Parliament. We, in Australia, are successfully solving our industrial problems by the establishment of wages boards and kindred tribunals; and if the British Parliamentary and other representatives who have been visiting the Commonwealth on recent occasions, with the object of inquiring into our industrial and social systems will only impress upon the people in the home land the necessity of adopting some of our methods and our so-called "experimental legislation," the dawn of a better and brighter era there, gradually but surely displacing the helldom of sweating and starvation, cannot be much longer delayed.

MECHANICS

The usual monthly meeting of the Mechanics Institute was held on Tuesday, the vice-president in the chair (owing to Mr McNaughton having been called away on other business). The secretary reported that 32 new books had arrived, and the committee inspected and passed them for issue. The treasurer's report showed: by balance last report, £34 17s 5d; receipts, £15 12s.
